## **TENDER CALL NOTICE**

Tender is invited from seed producing Companies / Corporations having their own production programme for supply of Certified Groundnut & Green gram seeds on FOR basis to all Districts of Odisha. The Tender document will be available in the office of undersigned from 11.09.2015 to 06.10.2015 up to 1.00 p.m. on payment of Rs.10, 500/- inclusive of VAT per set vide Cash/DD drawn in favour of OAIC Ltd. payable at Bhubaneswar. The details of application format and terms & conditions can be down loaded from our website [www.orissaagro.com](http://www.orissaagro.com). In case of downloaded form the tenderer has to attach a Demand Draft amounting to Rs.10, 500/- in favour of OAIC Ltd. with the tender document. The last date of submission of Tender document is **06.10.2015** up to **2.00 PM**. Tender document will be opened at **3.00 PM** on **06.10.2015** at the OAIC Head Office, 95, Satyanagar, Bhubaneswar-751007. The undersigned reserves the right to accept / reject any or all application(s) without assigning any reason thereof.

### **TERMS AND CONDITIONS**

**OAIC intends to supply 17,000 Qtls of Certified Groundnut seeds & 4,000 Qtls Green gram seeds at various destination points of Odisha during the period from 1<sup>st</sup> Nov.'15 to 15<sup>th</sup> Dec.'15. The variety wise details are available at Annexure-2 of the Tender document.**

1. Application received with incomplete /partial information and / or without supporting documents shall be rejected.
2. Application of a company/firm that has been blacklisted by the Govt. of India/other PSUs / any Ministry /Agency of Govt. of India/Any Department of Govt. of Odisha and/or any other Deptts./PSU of other States shall be rejected. The firm should submit a notarized affidavit in support of their claim.
3. OAIC reserves the right to call for original documents and /or any additional information/documents from the applicant(s).
4. Validity of the tender is till 31/03/2016 as per the OAIC's terms & conditions incorporated in this document.
5. The applicant must have experience in supplying bulk quantity( Order value minimum Rs.2 crore) of different high yielding varieties of Certified Seeds of Oilseed seeds & Pulses seeds to any Government /Semi Government/PSU and all related Documents / papers are to be attached as evidence.

6. The applicants should have minimum order value of Rs.2 crore in a single order from any Govt. agencies, PSU, State Govt., or Govt. owned federation etc. for bulk supply of certified seeds as indicated above in any one financial year out of last three financial years (2012-2013, 2013-2014 & 2014-15). The applicants should submit self attested photo copies of documents in support of their claim /information in this respect. Applicant should have minimum annual average turnover of the Rs. 2 crore in any one year during last three financial years and the same has to be audited/certified by the CA along with seal and signature.
7. The quality and quantity of the materials supplied is the sole responsibility of the supplier.
8. Application shall be submitted by the individual firms / company only and no joint ventures /consortium is allowed to apply
9. The tender is invited from Producers only and no back to back arrangement with traders will be allowed.
10. Packaging of seeds should be made in bags (appropriate packing materials) having level indicating the name of the applicant(producers only) along with the certification Tags in the name of the applicant(producers only) and other specifications as per the Seed Certification Norms of the state where certification has been carried out.
11. Modification of the information already furnished by the applicant will not be permitted after the tender is submitted / opened.
12. Annual Profit & Loss Account and Balance Sheets of past three years. (2012-2013, 2013-2014 & 2014-15) duly signed by registered C.A and or for Govt. Organisation Income Tax acknowledgement of 3 years.
13. After selection the selected firms shall have to enter into an agreement with OAIC for smooth execution of work.
14. National / State Level Seeds Corporations / Govt. of India Undertakings are exempted from submission of EMD, Cost of Tender document & Security deposit.

#### **PENALTY**

1. In case the Successful Tenderer / Supplier fails to supply the agreed quantities of required seeds within the time period specified by OAIC Ltd., OAIC shall be entitled to arrange the unsupplied quantity from the other supplier at the risk and cost of the said Successful Tenderer / Supplier.
2. In no case inferior quality stock will be received by OAIC Ltd. In the event such a stock is transported to the receiving point by the Successful Tenderer / Supplier and it happens so that it is being rejected for any reason, the Successful Tenderer / Supplier will have to take back the same on his own expenses. In such a case described above the Successful Tenderer / Supplier cannot claim the transportation cost and other ancillary expenses from OAIC Ltd.
3. In case the participating supplier fails to supply the agreed quantity of required seeds in time, OAIC Ltd. reserves the right not to accept the subsequent tender of the said supplier in future.
4. In case of any complaint received from the field on the quality of the seeds, the Successful Tenderer / Supplier would be liable to pay compensation to the farmers as per the claims / decision of the Consumer Court / other Courts/Govt. Besides OAIC will not pay any money for such supplied required seeds or the incidental / connected expenses incurred by the supplier.
5. OAIC Ltd will be indemnified by the Successful Tenderer / Supplier for the loss sustained in the entire process.

## **E.M.D. & SECURITY DEPOSIT**

1. The Tenderer has to provide 'EMD' of Rs. 10.00 Lakh vide Demand Draft drawn in favour of 'OAIC Ltd.' payable at Bhubaneswar, which has to be attached to the Tender document, failing which the tender will not be considered.
2. The Successful Tenderer will have to submit interest free Security Deposit of Rs.20.00 Lakh vide Demand Draft drawn in favour of 'OAIC Ltd'. The EMD will be converted to Security Deposit and the balance amount is required to be paid by the Successful Tenderer.
3. The Security Deposit in full or part will be forfeited for breach of agreement or the terms & conditions of the Tender and the decision of the Managing Director will be final & binding on the Successful Tenderer.
4. The Security Deposit will be refunded to the Successful Tenderer after 60 days of completion of supply of ordered quantity of seeds.
5. The 'EMD' will be forfeited if the Successful Tenderer do not supply the seeds for which he/they has/have participated in the tender.
6. The 'EMD' will be returned/refunded to the Unsuccessful Tenderer within 7 days of opening of tender on receipt of a request and tenderer will not charge any interest / compensation for delayed refund.

## **PROCEDURE FOR SUBMISSION OF TENDER:**

- a) The entire tender document is to be submitted on or before the last date duly filled in and signed on each page by the applicant.
- b) Tender is to be submitted in sealed cover super-scribing "**Supply of Certified Groundnut & Green gram seeds on FOR basis to all Districts of Odisha**". Applicants should invariably mention their name address etc. on left hand side of envelope for clear identification.
- c) A separate sheet showing variety wise quantity of seeds available along with complete address of the location of storage (State, District, and village/Town etc.) as per format given at Annexure-2 should be submitted along with the tender in a separate sealed cover superscribed as "**physical stock availability**".
- d) Conditional tender other than the conditions mentioned in the tender document will be liable for rejection.
- e) The sealed tender document along with the Annexure-1, 2 , 3 & 4 should reach The Odisha Agro Industries Corporation Limited, Head Office, 95, Satya Nagar, Bhubaneswar - 751007 through Registered Post/Speed Post/Courier Service/ Drop Box kept at Head Office on or before 06.10.2015 up to 2.00 p.m.
- f) Tender will be opened at 3.00 p.m. on 06.10.2015 in presence of members of the tender Opening Committee and the authorized representative of the tender applicants in which the sealed covers containing the tender document, general & technical information along with supporting documents & the location details(complete address) of availability of physical stock(Annexure-2) shall be opened. Financial Bid (Annexure-3) will be opened after physical verification of stock. However, the tender will be opened even in the absence of the applicants or their authorized representatives in the OAIC Head Office at 95, Satyangar, Bhubaneswar-751007 at above scheduled time.
- g) Applications received after the schedule date and time shall not be entertained.

- h) After opening of tender a team of officers will move immediately for verification of the availability of stock with the applicant as per the quantity, class and variety of seeds quoted by the applicant in the tender. After verification of the available physical stock, the financial bid shall be opened and supply order shall be placed with the selected tenderer. for supply of Groundnut seeds
- i) The tenderers are required to give following sealed covers containing documents/information as follows:
- (1) Sealed cover-I: Entire tender document along with other three sealed covers
  - (2) Sealed cover-II: Technical & general information along with supporting documents and undertaking as per Annexure-4.
  - (3) Sealed cover-III: Location details(complete address) of availability of physical stock.(As per Annexure-2)
  - (4) Sealed cover-IV: Financial bid giving variety wise rate of Ground Nut & Green Gram seeds. (As per Annexure-3)
- j) An undertaking that is required to be given along with the tender document is placed at Annexure-4. It is mandatory to sign the undertaking while submitting the tender document. Tender is liable for rejection if such undertaking is not attached with the tender document.
- k) If the last date of submission of tender & tender opening happens to be a holiday or the office remains closed due to any reason whatsoever the last date of submission of tender & tender opening will be the next working day.

**DISPUTE SETTLEMENT:**
