3. The manufacturers must submit valid manufacturing license of the product applied and Principal Certificate in favour of OAIC Ltd, Bhubaneswar.
4. The manufacturer must submit the CIB Registration Certificate of the product applied.
5. The manufacturer must submit certificate of registration / sale stock license within Odisha.
6. The manufacturer must be willing to issue Principal certificate of its product in the name of 314 SURAVI outlets.
